Section 4 ~ First Aid Measures

Precautionary Statement- Response

Inhalation: Remove source of exposure or move person to fresh air and keep comfortable for breathing. If exposed/feel unwell/concerned: Call a POISON CENTER/doctor. Eliminate all ignition sources if safe to do so.

Eye Contact: Remove source of exposure or move person to fresh air. Rinse eyes cautiously with lukewarm, gently flowing water for several minutes, while holding the eyelids open. Section 5 ~ Fire Fighting Measures
